Starting with this edition of the Conference, the Romanian-German University of Sibiu has decided to reposition and offer a general name to our international scientific conference: *Society, Economy, Law, Technology and Humanity (SELTH)* that relates to the changes that occur in our society in the context of the challenges of the EU 2020 strategy.

The Europe 2020 strategy is the European Union's ten-year growth strategy. It is about more than just overcoming the crisis which continues to afflict many of our economies. The objective of the economical growth is inherent to the management of the companies, to the education of consumers for developing an intelligent consumption, for the reduction of poverty of the population in favor of research and innovation.

We as individuals must understand the main social, economical and legal implications of the EU 2020 strategy on the society and for the organizations. Therefore we have established several tracks for the 2015 International Scientific Conference, that can hopefully will offer several clear and applied answers:

1. Economics and Management;
2. Law and Administrative Sciences;
3. Human and Social Sciences;
4. Applied Sciences and Engineering.



1. PAPER FORMAT AND PUBLISHING

The papers will be written in **English / German / French** (if English / German / French is not your native language, please make sure that the papers are written in proper academic language) and will be **between 6 and 14 pages long** (always even pages). **Papers must follow the guidelines described in 2015 Template that you can download from the conference website.** The organizing committee reserves the right to reject submitted papers that do not comply with this format.

The organizing committee **will not accept papers with more than 4 co-authors.** One author can submit an individual paper or two papers in collaboration. All submitted papers will be subjected to a double blind review process as to the following elements: originality, significance, clarity, contribution, results.

Accepted and presented papers **will be published in:**

- The Annals of the Romanian-German University of Sibiu – Economics (ISSN: 2392 - 733X; ISSN-L: 2392 – 6791) – the journal in the process of being indexed in BDI (International Data Base).
- The Annals of the Romanian-German University of Sibiu – Law and Administrative Sciences (ISSN: 1583-428X).
- The CD Conference Proceedings with ISBN.
